CHAIR'S REPORT

Purpose

- 1. The purpose of this paper is to provide an update to the Board on activities and matters involving the Chair which are not covered by other papers on the agenda.
- 2. Annex A to the paper gives a full list of the meetings and events I have attended since the last Board meeting and I am happy to take any comments or questions on those. The main body of the paper highlights any particular points arising from my meetings which I think you should be aware of.

Meeting with Aileen Campbell, Minister for Public Health and Sport, 30 November 2016

3. The Chief Executive and I met with the Minister to discuss the Public Health Review. We reinforced our support for the establishment of a new, national public health body and our commitment to assist constructively in its formation. Subsequent feedback from the civil servants present about the meeting was positive, and since then of course we have had confirmation of the intention and timetable for establishing the new organisation.

Senior Leaders' Forum, 11 January 2017

4. The Chief Executive and I also attended the NHS Scotland Senior Leaders' Forum on 11 January. Gerry will say more on this in his report, but all I would emphasise at this stage is the clear expectation of Scottish Government that both the territorial and national boards are now expected to increase the extent of shared resource and financial planning. This will have some implications for our budgeting and use of shared services and we will report back on this as these become clearer.

Health Inequalities Forum, 24 January 2017

5. This was an internal event, one of a regular series which Health Scotland holds in partnership with other organisations. This particular event reported on research we have supported into the challenges faced by disadvantaged groups, in this case the homeless and female asylum seekers, in accessing health services. The topic itself was fascinating but more generally these events are a useful way of getting a more in-depth taste of some of the work we carry out in the field, something I know that Board members regularly express an interest in. I know that any Board member interested in attending future forums would be very welcome.

NHS Scotland Chairs' meeting, 30 January 2017

6. The Chairs received a presentation from Bill Thomson, Commissioner for Ethical Standards in Public Life in Scotland, on a research project they are undertaking into the value of diversity on public boards. I will be attending a further meeting on this with the Commissioner and a small group of Chairs on 16 February. There was a brief update on Sir Harry Burns' review of targets, which is scheduled to report in September, and further reinforcement from the Minister for Public Health and Sport on the importance of joint planning across the Boards.
