6. Schedule of Board Business

Ms D Thomas, Executive & Governance Lead (E&GL) drew the Board's attention to the Board Seminar dates which had been added to the Board Schedule of Business together with the Events update which will now become a standing item at future Board meetings.

A request was made to give attention to the sequencing of governance considerations on "Healthy Working Lives Service Redesign" update. To be placed on November Board agenda. An update to be given at the June 22 Board meeting.

7. Quarter 4 Performance Report

(HS Paper 12/17)

This was the final 2016/17 Quarterly Report to the Board. It was noted the Impact Report will come to the Board in June.

The paper reports NHS Health Scotland's key achievements, progress against corporate priorities and risks and performance against the Delivery Plan 2016-17 in the final quarter of the business year (Q4)

Mr Tim Andrew, Organisational Lead for Improvement (OLI), drew the Board's attention to several points from his paper.

Some concern was expressed in relation to the section starting on page 4 "By the end of Q4, 70% of our work was fully completed as planned for the year". The Board felt that external perception of this level might be very negative. It was suggested rewording this. It was agreed Mr G Dodds, Director of Health Equity (DHE) would liaise with Mr. Andrew (OLI) on this.

It was noted there was an error on page 4, first paragraph, sentence commencing "The impact assessment informed......"underground coal gasification" should be replaced with "unconventional oil and gas".

The Board noted the paper.

8. Health & Social Care Delivery Plan Implementation

Mr G McLaughlin, Ms M McCoy and Dr A Fraser attended a session organised by CoSLA. Senior public health figures from the NHS and senior leaders from local government and Integrated Joint Boards attended. There had been a series of table discussions and an address was given by the Minister for Public Health. Mr Colin Mair, Chief Executive of the Improvement Service and Dr Andrew Fraser, Chair of the Directors of Public Health, gave presentations on The Intelligence of Public Health.

Scottish Government agreed to write up a model on what the public health priorities might look like and consult with interested parties in late spring, early summer.

There were no further significant developments related to the public health element of the Health and Social Care Delivery Plan.

Mr McLaughlin indicated that as well as territorial boards working together the 8 national boards were expected to work together on their contribution to the implementation of the Delivery Plan. NHS Health Scotland will lead on a piece of work bringing forward options around how boards manage publications and marketing based on

An update was given to the Board on the Chief Executive and Dr Fraser's attendance at the Health & Sport Committee to give evidence on 16 May 2017. NHS Health Scotland was acknowledged for producing high quality work.

The Chief Executive and Dr Fraser were invited to attend the first meeting of the new Public Health Oversight Board on 22 June. The Oversight Board will meet four times per year and will be jointly chaired by Mr Andrew Scott, Director of Population Health, Scottish Government, and Ms Paula McLeay, Chief Officer, Health & Social Care, CoSLA.

Although NHS Health Scotland was not directly affected by the cyber attack, the response from IT and all staff involved had been exceptional. The Board put on record their thanks for a very strong effort.
