Leadership

- All 32 LAs and both National Parks have appointed a place standard lead(s).
- Concept of an individual Community Champion for each LA on hold.
- Place Standard Lead for key national & regional organisations to be developed.

Legislation, Policy & Strategy

- Focus on how the Place Standard may support elements of the Planning Bill, particularly on the development of Local Place Plans (LPPs).
- The Planning Minister referenced the potential role of the Place Standard in developing LPPs when giving evidence to the Local Government and Communities Committee and the Finance and Constitution Committee.
- LPPs have come under particular scrutiny through the parliamentary process and the role of the Place Standard in supporting this area will continue to be developed.

- Plans for a 2 day international conference have now commenced. This will coincide with the launch of the improved place standard in summer 2019.









Around Scotland - a few examples

Renfrewshire Community Planning Partnership Local Outcome Improvement Plan – Online Questionnaire

- Overall, 773 respondents completed the place standard tool.
- 68.6% (530) of the total responses were collected through the online questionnaire in English.
- This proved to be the most effective way to engage with high volume of residents over the short period of time.
- The surveys were available in English and Polish language.
 Renfrewshire CPP worked closely with Renfrewshire Polish Association to translate surveys & it results into Polish language.

Around Scotland - a few examples

West Lothian - Stoneyburn Locality Plan Steering Group

Moving Around "Kids can't cycle to the high school as the roads are dangerous"

Traffic and Parking "Issues with the Community Centre and NHS car park. Parent use it during school runs"

Public Transport "Buses stop running around 3 to do the school run So if you go to a place, you can be stuck there until the service is back on"

Play and recreation "Cycling is where the village is lacking." Standards for Community Engagement Stirling & Aberdeen City Councils

Mapping Findings onto Local Policy Frameworks Aberdeenshire Council & A&DS – Portlethan. *"Great engagement from Community Council and local businesses"* and *"great commitment from the council to follow through".*

3-Day Pathfinder - Prompted a wide range of initial local initiatives from: -

- ASDA car park improvements to
- Pop-up cafes in isolated parts of town to
- New spaces for people to meet and regenerated local centres.

Around Scotland - a few examples

Falkirk Locality Planning Grangemouth, Bo'ness' and Upper Braes villages

Method - On-line, Community focus groups and Schools workshops (540 responses)

Key Learning

- The visual nature and plain English used within the standard are plusses,
- The structure of the standard helps focus groups and workshops,
- The standard was very successful with young people,
- We found that the standard lacked the ability to record sufficient information on equalities characteristics
- Local people reported duplication within the standard and that 21/2 hours was too long to complete the standard,
- We needed to simplify the standard for children with special needs.

Next Steps


- Reducing the standard to 7 categories
- Simplifying the scoring to a scale of 5
- Ensuring that the required equalities information is captured at the start;
- Developing an on-line version of our new tool on Citizen Space;
- Doing more targeted planning to ensure that we have a balanced consultation across different age groups; and
- We won't call it the Place Standard bearing in mind we have changed it.


