#### PROPOSED DATES FOR FUTURE BOARD/COMMITTEE MEETINGS

## **Purpose of Paper**

1. This paper set out the proposed dates for Board and Committee meetings in the next financial year, April 2017 to March 2018.

### Background

- 2. The dates and times for Board/Committee meetings in 2017/18 have been reviewed at Corporate Management Team (CMT) and are now presented to the Board for consideration and approval. January to March 2017 dates have previously been approved by the Board and are given for information purposes.
- 3. The schedule of dates in the summer months was considered. For 2017/18 it is proposed that some dates will move from earlier in the year to September. This is to try to ensure a more even spread of Board and Committee business particularly during the month of June, which has in the past been a busy month. June Health Governance Committee and August Audit Committee and Board have been scheduled for September 2017, whilst continuing with the maintenance of a Board and Committee free July.
- 4. The pattern of Friday meetings has been retained with a variation to a Thursday schedule for Health Governance Committee from 1 April 2017 onwards; a Wednesday or Friday schedule for Audit Committee and a Thursday for the series of full day June meetings of the Board (part 1 and 2) Audit and Remuneration Committee (avoiding the NHS Conference taking place that week).
- 5. A series of 4 Board Seminars are usually scheduled. However for 2015/16 an additional Seminar took place in August 2015. For 2016/17 an additional Seminar was also scheduled in August 2016 with the December 2016 Board Seminar now being used for the purposes of Board Development. It is proposed to maintain the schedule of 4 Board Seminars for 2017/18 and add another date if business needs necessitate this.

## **Finance and Resource Implications**

6. Most meetings are expected to be accommodated in internal meeting rooms. Where this is not possible, we will book external accommodation, which will incur a financial cost.

- 10. A member of the Communications Team tweets "live" from Board meetings.

#### Risk

- 11. Meeting rooms in our office accommodation at Gyle Square, Edinburgh and Meridian Court, Glasgow are shared with the other NHS tenants, resulting in higher demand for large meeting rooms. We may therefore have less flexibility on the preferred location/venue of our Board and Committee meetings.
- 12. If meeting dates are not approved and diarised in good time it may be difficult to secure a quorum for a meeting.

#### **Equality and Diversity**

13. All meetings will be held in accessible venues. Members of the public attending Board meetings will be asked to notify NHSHS staff of any access requirements.

#### Sustainability and Environmental Management

14. Those attending Board and Committee meetings are encouraged to use sustainable transport methods.
